## AMENDMENT #7 TO THE FOOD SERVICE PARTNERSHIP AGREEMENT

This Amendment is made and entered into by and between Rappahannock Regional Jail ("Client"), and Summit Food Services, LLC ("Company") (collectively "the Parties").

WHEREAS, Client and Company have entered into a certain Food Partnership Agreement (the "Contract"), effective May 16, 2017

WHEREAS, Client and Company have agreed to extend the partnership for additional three years, beginning July 1<sup>st</sup>, 2022; and

WHEREAS, the parties now desire to amend said Agreement upon the terms and conditions stated herein.

NOW, THEREFORE, the parties, intending to be legally bound hereby, mutually agree as follows:

- 1. Company shall invest into remodel and retrofit of Client's Officers Lounge, exhibit "A"
- 2. Company shall introduce the Grab and Go program within the confines of the Officers Lounge, exhibit "A"
- Beginning July 1, 2022, price of Officer Meals shall increase by same index outlined in Section 3.8-Contract Adjustment, and Inmate Meals will remain at the current rate through June 30<sup>th</sup>, 2023
- 4. Beginning September 1<sup>st</sup>, 2021 Company shall increase commissions paid to the Client from Outside/Inside sales program, from current 20% to 25%.
- 5. **Contract's Section 3.8-Contract Adjustment** shall stay the same, with following notes:
  - a. CPI index "Food Away from Home" for month of May for the previous 12 months period shall be used to determine Inmate and Staff Meal price adjustments, and
  - b. Any agreed Inmate and Staff Meal adjustments shall not exceed 3.5%, annually

This Amendment is effective as of September 1st, 2021. All other terms and conditions of the original Contract (as modified from time to time) shall remain in full force and effect unless otherwise amended as provided in the Contract.
